Several Queens Programs Get Go Ahead

Queens Borough President Donald R. Manes has reported that the Board of Estimate last week approved a number of programs covering various neighborhoods in the Borough.

"These actions are in the fields of housing, transportation, child care, health and other vital areas of government services," Manes commented.

The Borough President said the Board did the following:

- Approved Addiction Services Agency contracts as follows: Woodside Halfway Center, 48-09 47th St., Woodside, \$75,174; Samuel Field YM-YWHA, 58-20 Little Neck Parkway, Little Neck, \$111,262; Long Island Jewish-Hillside Medical Center's South Shore Division, 327 Beach 19th Street, Far Rockaway, \$80,516; and Samaritan Halfway Society, Inc., 130-15 89th Road, Richmond Hill, \$15,000.

- Continued through September 1976 two express bus lines to Manhattan operated by Green Bus Lines, Inc. They are the QM-17 serving Far Rockaway and the QM-18 from Richmond Hill.

- Allocated \$15,500 to the Hellenic American Neighborhood Action Committee, headquartered at 22-55 31st St., Astoria,

for the operation of a Senior Citizen Recreation Project which will offer a variety of leisure time activities for older residents in Queens, Brooklyn and Manhattan. The appropriation is through the City Department for the Aging and runs through March 31, 1976.

- Continued funding for five methadone maintenance treatment clinics, located as follows: two at Mary Immaculate Hospital at New Hyde Park, \$358,953; and two at Jamaica Hospital, \$539,713. All five projects are part of the City's Methadone Maintenance Treatment Program conducted by the Health Department.

- Continued the maximum real estate exemption for Dayton Beach Park No. 1 Corp., a limited profit housing development running from Beach 84th to Beach 90th Streets in Rockaway Beach.

- Approved a lease for a group day care center at 18-40 20th Ave., Astoria. Some 9,800 square feet of space will be used, at an annual rental rate of \$75,174. The funding will be from the Agency for Child Development.

Tax Exemption For Seniors

Senator James L. Buckley (C-R, N.Y.) today introduced a bill which would give any taxpayer a \$1,000 deduction for each senior citizen for whom the taxpayer provides free housing. The \$1,000 deduction would be over and above any deductions presently given to taxpayers who support dependents.

Although the bill is directed primarily at keeping families together, Senator Buckley said that the \$1,000 deduction would be made available to taxpayers who provide free housing for any senior citizens, 65 years or older, related or not.

Financial pressures, he said, have "combined with the extraordinary mobility of contemporary society to erode our traditional sense of family responsibility." "Many of today's young Americans reach maturity without exposure to the insights and fortitudes of age."

Senator Buckley said this bill "would assist taxpayers who are trying to keep their family, young and old, together in one household. It would provide a significant financial incentive to bring older Americans into private homes. It would encourage children to invite parents to live with them, as was once the custom in America."

The bill, he said, would offer several advantages. "It would be far less costly to taxpayers than would the construction, with federal funds, of separate housing projects for senior citizens. It would allow them a more humane and supportive atmosphere than would their segregation into unfamiliar and impersonal surroundings.

"By emphasizing familial responsibility toward the aged, it would turn our national attention to a neglected verity: that unless we care for one another as individuals, we lose our ability to care at all for our neighborhoods and communities, out people and our country.

"By enacting his legislation, Senator Buckley said, "Congress can display, not only its commitment to older Americans, but also its realization that their problems require from us new approaches, fresh thinking, and a greater reliance upon the generous responsibility of the American people.
