	MANDATORY CLOTHING REGULATIONS 1. Name of player is MANDATORY from the first day of the event. 2. From Quarter Finals onwards, doubles partners must wear clothing of similar design. 3. From Quarter Finals onwards, opposing players must wear clothing of significantly different colors.			
On Court Doctor	On Court Doctor will be on duty throughout the competition at the tournament Venue.			
	Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples.
