CONDITION

General

This BEC Elite Circuit Tournament will be played in accordance with the Laws of Badminton, the BWF General Competition Regulations and Badminton Europe Elite Circuit Regulations. In case of any dispute, the Referee's decision shall be final.

Member and/or organizer may be liable for claims originating from the damages incurred by the participants and/or any other persons, arising from or in connection to the particular BEC Elite Circuit tournament, according to local Law. Badminton Europe is not liable for any such claims, actions, damages, costs or expenses of any nature whatsoever, including but not limited to injury or loss to person or property, arising out of or in any way related, directly or indirectly, to the particular BEC Elite Circuit tournament. It is recommended that Member and/or Organizers purchase a proper Insurance Policy that would cover their potential legal liability (see Elite Circuit Regulation 3.6).

The organizing Member can cancel a tournament in case of force majeure. Such cancellation must be announced at least 15 days before the start of the tournament. If a cancellation is announced less than 15 days before the start of the tournament, then the Member organizing the tournament is liable for any expenses incurred by third persons (players, coaches, umpires, team managers etc.).

Badminton Europe is not liable for any costs incurred by third persons because of a cancellation of a tournament. (see Elite Circuit Regulation 3.4).

Entries

- Only entries that are entered by Members through the online system at https://bwf.tournamentsoftware.com/tournament/FB0F90A0-2CE2-47BF-AFB9-C355E36BB527 will be accepted. If needed, Members can obtain the required username and password from BWF's Senior Events Officer: s.ramachandran@bwf.sport.
- Entry deadline is Tuesday February 13th, 2024 23h59 BWF headquarters time (+08h00 GMT).
- After the deadline, the BWF Online Entry System will send a notification confirming receipt of final entries to all participating Members. Receipt of this notification is the conclusive evidence of receipt of entries before the deadline.

Compliance with GCR 7.9: "In making or authorizing entries, the Member concerned is reconfirming its acceptance, and acceptance by the Players being entered, of the BWF's regulations and Disciplinary processes."

Events

- The draw sizes of the main events will be as follows: 32 MS, 32 WS, 24 MD, 24 WD and 24 XD.
- In accordance with regulation § 9.2 and § 9.3 in BWF Statutes, Section 5.3.3.1: World Ranking System, an event must contain at least 8 (eight) competitors in the first published version of the main draw. If the required number of competitors is not met in the first published version of the main draw, this particular event shall not count towards any ranking, i.e. BEC Elite Circuit Ranking and BWF World Ranking.
- In accordance with regulation § 9.4 in BWF Statutes, Section 5.3.3.1: World Ranking System, the first published version of the main draw of an event must contain at least 1 (one) entry from a Member other than the hosting Member. If an event does not contain at least 1 (one) entry from a Member other than the hosting Member, this particular event shall not count towards any ranking.
- Badminton Europe is not liable for any costs incurred by third persons (players, coaches, umpires, team managers etc.) because of an event not having enough competitors to count for the rankings (see Elite Circuit Regulation 3.3).
- Members will be informed about which of their entries have been accepted into the Main Draw, which are required to qualify, and which are on the lists of reserves.
- Seeding and draw will be done by Badminton Europe, based on the World Ranking as mentioned above.
- The final frame schedule (with the exact planned conclusion of all matches) shall be made at least 20 days before the start of the tournament and shall be published on the organizer's website.
- Players shall not plan their departure less than two (2) hours after their last match is planned to conclude. If a player is unable to compete due to early departure, he/she shall be penalized by Forfeiture of rewards (removal of Elite Circuit ranking points and shall not be awarded prizes or prize money). Badminton Europe shall propose to BWF that the gained BWF ranking points are also removed.

• Please ensure that the Secretary of the Committee of Management is informed immediately when a player has to withdraw, preferably together with the reason.

Attention:

Any withdrawal after the Monday immediately preceding the draw (February 26th, 2024), for any reason whatsoever, renders the Member concerned liable to an amount of US\$ 150,00 for the inconvenience caused by the withdrawal (as defined in BWF General Competition Regulations).

Any player not showing up at the tournament, without having been withdrawn in advance, renders the Member concerned liable to an additional amount of US\$ 500,00 for the inconvenience caused by the "no show" (as defined in BWF General Competition Regulations).

Match conditions

- Competitors must be prepared to play at the times quoted in the Order of Play for the events for which they have entered. No exception shall be made to this rule.
- Matches will be played in according with BWF Laws and Regulations.
- The tournament's official shuttlecock is the FZ Forza VIP.
- Testing for the use of drugs can be conducted throughout the tournament. Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples. Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE). - During the entire tournament, two courts will be equipped to enable betting. On these courts matches will be played as "followed by".
- Section 2.4 of the BWF Statutes (Code on The Prevention of The Manipulation of Competitions) relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament. To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, shall respect the principle of fair play, and shall not attempt to influence the course or result of a game or match. Every person has an obligation to report to the BWF

any approaches by anyone to gather inside information or to change the outcome of a match(es). For more information, please refer to BWF's website: https://corporate.bwfbadminton.com/integrity/anti-match-fixingoverview/

- During the event, stringing service will be present.
- The managers' meeting is scheduled for Wednesday March 13th, 2024 at 20h30 in a signposted room at the hotel.
- The matches will be played on Gerflor mats.
- Training courts in hall 2 can only be used upon availability. From February 15th, 2024 a schedule of available courts will be published on the website. Request for a training court is only possible by sending an e-mail to <u>secretary@dutch-international.nl</u>.

Clothing and advertising

- Color, design, lettering and advertising on clothing shall be regulated by BWF General Competition Regulations § 20 to 24. Any breach of these regulations will be forwarded to BWF.
- It is mandatory that partners in doubles wear the same color of the T-shirt and shorts/skirts at all time during play in both the qualification and the main draw.

Failing to do so shall result in an administrative fine of 100,00 EUR.

- Entry fees must be paid before a competitor plays his/her first match in the tournament.
